

School of Business Admission Scholarship Scheme for Outstanding Local Students (JUPAS route)

Guidelines (2026 entry):

For JUPAS (Band A) applicants who obtained an aggregate HKDSE score of 23 or above for 3 core subjects (English Language, Chinese language and Mathematics) + 2 best elective subjects in one sitting, and Level “Attained” in Citizenship and Social Development#.

“Attained” in Citizenship and Social Development will not be included in the admission score calculation.

Notes:

- i. *The Scholarship is eligible to JUPAS (Band A) applicants who are admitted to JS2110 BBA (Hons) - Accounting and/ or JS2120 BBA (Hons). Qualified students will be automatically considered. The School reserves the right to make final decision as to the list of recipients.*
- ii. *The Scholarship will be terminated if the recipient ceases to study at HKBU BBA at anytime in the course of his/ her studies. The School of Business reserves the right to ask for full refund of the scholarship awarded.*
- iii. *Awardee who have received the Global Experience Scholarship (GES) will not be eligible to apply for the BBA Global Experience Support Scheme to avoid double benefits.*
- iv. *The School may adjust the amount of scholarship awarded accordingly if recipient concurrently receive other scholarships or awards from HKBU or other donors that subsidize his/ her tuition fee. The general principle is the total amount received (excluding the GES) does not exceed the actual tuition fee paid, i.e. HK\$47,000.*

Remarks:

- i. Recipient has to maintain a cGPA of 3.0 or above by the end of each academic year in order to receive the scholarship award of tuition fee for the next academic year.*
- ii. The GES will be distributed when the students have confirmed participation of recognized overseas activities, such as double degree programme, exchange programme, MAP, SLGIP, etc.*

The general entrance requirements for JUPAS admissions with effect from 2026 entry are stipulated as follows:

Non-Chinese speaking applicants can use GCE, GCSE and IGCSE Chinese or HKDSE Applied Learning Chinese in lieu of HKDSE Chinese Language to meet the Chinese language requirement (unless specified otherwise by individual programmes).

Remarks:

- i. *One of the elective subjects must be Category A subjects (excluding Extended Part of Mathematics (Module 1 or Module 2)).*
- ii. *Extended Part of Mathematics (Module 1 or Module 2) and Category C subjects (Other Languages) at Grade C or above can be recognized for fulfilment of the second elective requirement.*

In general, the scores for Category A subjects are converted as follows:

$5^{**}=7$, $5^*=6$, $5=5$, $4=4$, $3=3$, $2=2$, $1=1$

The scores for Category B subjects are converted as follows:

Attained with Distinction (II) =4, Attained with Distinction (I) =3, Attained=2, Unattained=0
