Hong Kong Baptist University, School of Business and Kozminski University, College of Management and Finance

BACKGROUND

A MOU between HKBU School of Business and Kozminski University was signed in January 2020, establishing a partnership to offer a 2+2 Double Degree Programme to undergraduate business students. Upon completion of the programme, students will be awarded two degrees in business, one from HKBU and one from KU. This leading Programme is designed to provide highly aspiring students:

- Learning opportunities in business in Hong Kong and Poland
- Global mindset and essential skills to confront future challenges in business environment
- A platform to build network and develop connections across the two cities

ABOUT KOZMINSKI UNIVERSITY

Kozminski University (KU) is our School-level exchange partner in Poland. KU is the only institution in Poland crowned AACSB, EQUIS and AMBA, verifying its high standard of education. AACSB, EQUIS and AMBA are global leading business education accreditation bodies, placing heavy emphasis on quality assurance and demanding accredited business schools to maintain assurance of learning system.

In addition, KU is one of the best business schools in Central and Eastern Europe, receiving Financial Times rankings in 2022: 52nd in European Business Schools.

PROGRAMME STRUCTURE & CURRICULUM

The Finance and Accounting Programme in KU is a three-year programme. Participating BU BBA students will be admitted to KU in their 2nd term of their 2nd year of study and return BU in their 4th year of study, after spending three semesters in KU.

The timeline of the programme is illustrated below:



- *International Mobility Window*

Participating BU students are allowed to join an international exchange programme during the 5th semester in KU in the framework of ERASMUS+ programme for EU exchange. Students can choose from a multitude of universities where they would like to spend a semester abroad. No extra payment is required for participation.

- *Obligatory Internship*

Participating BU students will be required to complete a mandatory 3-week internship as a part of their core curriculum at KU. The internship is not constrained to any particular jurisdiction with the students having an opportunity to take an internship internationally. KU's Career Office will provide assistance in the job search process.

STUDY PLAN

Participating BU students will follow the original study plan to enroll in courses of different categories in the first three semesters. During their stay at KU, they are preregistered to courses which are mostly business relevant to maximize their learning abroad. Then they will return to HKBU for the final two semesters to make up the remaining required courses, including BBA Project and GE Capstone.

Students are required to submit credit transfer application to the Academic Registry every term for credit transfer approval directly after obtaining the course results at KU.

ELIGIBILITY

For January 2024 Admission, students meeting the following requirements are welcome to apply:

- Current BBA students in Year 2 who are: 1) in FIN or ACCT Concentration, or 2) intend to pursue double concentration in FIN or ACCT*.
- Local or non-local students
- Attain cGPA 3.0 or above
- Good command of English (IELTS 6.0/ TOEFL iBT score of 79 or above)

**Students are required to complete “FINE2005 Financial Management” and “FINE3015 Corporate Finance” by the end of semester 1, 2023-24AY.*

TUITION FEE

Students are required to pay HKBU tuition fee following the u-wide payment schedule.

SCHOLARSHIPS

Local student accepted to the HKBU-KU Double Degree Programme is eligible to apply for the *Global Experience Support Scheme* and *Mr. Mai Shi Song Scholarship for BBA Double Degree Programmes* offered by the School of Business, to receive a minimum of HKD\$40,000 scholarship yearly.

APPLICATION

Interested students who meet the admission requirements are welcome to submit application on or before **20 October 2023 (Friday)** by completing the online application form. Late application will not be considered.

SELECTION

A holistic approach will be adopted to assess students.

Criteria including academic ability, communication skills, suitability to the programme (study plan) and non-academic achievements will all be considered. Shortlisted students will be invited a selection interview held in late-October.
